

President's Report

The Institute of Public Administration Australia (IPAA) Tasmania has been busy in 2023-24 working to deliver a program of events and insightful content for the benefit of our members. We've also been exploring new ideas for how we can best generate connection and collaboration opportunities for public sector professionals going forward.



Key highlights in our activities over the past year have included sold out public policy, leadership and networking events, the launch of the new IPAA Tasmania Podcast Series, *Public Purpose Conversations*, and the reinvigoration of the IPAA Tasmania website to improve access to content offerings of IPAA Tasmania and other IPAA chapters.

As part of its continued ramp up to full operation again, in 2023-24 the IPAA Council resolved to reintroduce membership fees in the 2024-25 financial year, having suspended fees for the past few years we rebuilt member offerings following the COVID-19 pandemic. Our membership fee structure will remain modest for the next financial year, however, in recognition that IPAA Tasmania is continuing to scale up our range of member benefits.

We have successfully reengaged with the Tasmanian State Service Graduate Program regarding annual IPAA Membership for all participants in the program, and it has been great to see graduates attending our networking offerings this year.

Planning and delivery is already well underway for our 2024-25 program of events. In addition to our annual flagship events including the State Budget Briefing, we look forward to reinvigorating our highly popular IPAA Connections networking series, and reintroducing the IPAA Public Sector Excellence Awards, providing public organisations with the opportunity to recognise outstanding work and endeavour across the public sector.

My sincere thanks goes to fellow members of the IPAA Tasmania Council, who have continued to generously lend their skill, time and effort to bring together IPAA events and content, and to keep the 'back-end' administrative tasks ticking over. I would also like to thank those other members and supporters who have contributed to our work program this year; our members, partners, champions, facilitators, presenters and volunteers. We can't do it without you.

We look forward to working with you in the coming year and continuing to provide opportunities for interesting and relevant public purpose discussion, thought leadership and collaboration across all areas of the public administration profession in Tasmania.

Finance Report

Copies of the Financial Statements for the year ended 30 June 2024 are provided with this report.

Pursuant to section 24 of the Associations Incorporation Act 1964 IPAA Tasmania is exempt from the requirement to obtain an independent annual audit as its annual revenue is below \$250 000. Despite that an audit of the 2023-24 financial statements will be arranged and completed post the annual general meeting. This audit will be arranged by requesting assistance of another member agency.

IPAA operations and finances had an increase in activity during 2023-24 from 2022-23.

Summary points to note from the financial statements are:

- A deficit of \$2,664 for the year was achieved, contributing to total equity decreasing to \$37,152.
- In respect of Income:
 - The Association's council determined that due to the continued impacts of the Covid pandemic that membership fees for 2023-24 financial year would continue to be waived. Revenue for memberships continued to be \$0 for 2023-24 consistent with 2022-23.
 - There was an increase in Seminar income to \$7,536 from \$0 due to seminars recommencing during 2023-24.
- In respect of Expenses:
 - Total expenses increased to \$10,290 from \$5,196.
 - The increase mainly related to:
 - an increase in seminar expenses relating to the IPAA events that were conducted.

Given that IPAA Tasmania has now increased activities for members back to a pre Covid level, the Council has approved reinstating memberships for 2024-25.

On behalf of Council I would again specifically like to thank Loraine Kemble-Smith for her voluntary assistance in managing IPAA's finances.

Note 1: Statement of Significant Accounting Policies

(a) Basis of Preparation

The financial statements have been prepared on the basis that the Association is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (Tas). The Association is an incorporated entity. In accordance with the reporting requirements of the Associations Incorporation Act (Tas), the Association has complied with the following applicable Australian Accounting Standards and Urgent Issues Group Consensus View of AASB 1031 Materiality. No other applicable Accounting Standards, Urgent Issues Group Consensus Views or other authoritative pronouncements of the Australian Accounting Standards Board have been applied. The financial statements have been prepared on an accrual basis and are based on historical costs unless otherwise stated in the notes. The amounts presented in the financial statements have been rounded to the nearest dollar.

(b) Revenue

Membership subscriptions are recognised as revenue on the issue of membership renewals. Non-renewal of memberships are reversed out of revenue. Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. All revenue is stated net of the amount of goods and services tax (GST).

(c) Receivables

Trade and other receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets. Trade and other receivables are recognised at the nominal transaction value without taking into account the time value of money.

(d) Payables

Trade and other payables are recognised at the nominal transaction value without taking into account the time value of money.

(e) Goods and Services Tax

(GST) Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables

and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Balance Sheet.

(f) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax.

(g) Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.
